Christopher Mark Cochran, 64, passed away in Altamonte Springs, Florida on August 23, 2022. He is the son of Betty Jo Short Cochran and the late John Presley Cochran of Tallahassee. A graduate of FSU's College of Business, he had more than 35 years of banking experience and was one of the founders of First Colony Bank in Maitland. Chris was respected as one of the finest commercial lenders in Central Florida.
