Born June 8, 1929 in Worth County, Iowa; died May 22, 2011 in Orlando, Florida.

He attended school in Lake Mills, Iowa, served in the Navy in the Korean War and graduated from the University of Iowa.

From college he moved to Chicago to work for the Harris Bank in the trust department, as well as Standard and Poor's Intercapital before starting his own investment firm, Capital Supervisors, with his two partners. He retired from the firm in 1990.

His great source of pleasure was coaching youth baseball. He coached several teams on which his sons played.

He and his wife, Donna, have lived in Florida and northern Wisconsin for the past 20 years. He is survived by his wife and their two sons, Erik of Orlando, FL, and Dirk of Denver, CO, Dirk's wife, Kari, a sister, Leona Johnson, of Osseo, WI, and nieces and nephews.

Memorial services will be held in Glen Ellyn, IL, at Leonard's Funeral Home and his ashes will mix in the waters of Planting Ground Lake in northern Wisconsin where many wonderful summers were spent and at Silver Lake Cemetery in Lake Mills, Iowa, where his memories are dear.
