It is with great sadness that we announce the passing of Jayantkumar Shankerlal Pandya on March 22, 2020, at the age of 77 years.

Jay was a native of Rajkot, India where he spent his childhood years. He received a degree in Civil Engineering from IIT Madras (now Chennai). He went on to get his MBA and move to the United States. He lived in Mt. Laurel, NJ for much of his life and then retired in Ormond Beach, Florida to be close to his children and grandchildren.

Throughout his career, he became involved (and later become an Expert in Project Management) in some of the world's largest civil engineering projects such as the Channel Tunnel between France and England and Boston's Big Dig. He was involved and was key to the start of the of Construction Litigation practice at Deloitte. He retired as a partner from Deloitte.

In his free time, Jay enjoyed watching all sports and enjoyed playing golf and tennis. Recently, his favorite sport to watch was his grandson's soccer games.

Jay is survived by his loving wife of 50 years, Aruna, sons Mehul (Neha) and Nirav (Simoli), grandson Neil, and granddaughter Riana.

“ Dear Aruna, Mehul, Nirav and family,
Nothing can be said that would soften the blow of losing the kind and gentle man that we all knew Jay to be.
I first met Jay in 1980 when I was hired at MDC Systems. My first day on the job I hadn't a clue about what I was doing there, but Jay had faith in me and got me up and running in short order. Still, it took several years before I appreciated his sense of humor.
In 1985 we worked together in Saudi Arabia at a dusty, desert bound construction site that didn't have much going for it. Every morning we would brush away the fine dust that had seeped into the trailer overnight so that we could share tea together as we worked. And every day we bolted through the blazing mid-day heat to the mess hall for lunch. We spent nearly all our waking hours together. On these projects, Jay was a “big picture” thinker but I was constantly vexed by the details that didn't always fit his big picture. Consequently, Jay and I were often at loggerheads over an analysis. We had many a spirited discussion that probably alarmed the staff but we always managed to produce a meaningful report, thanks to Jay's insights.
Jay was very important to the arc of my professional life. I had left the construction analysis business in the early 1990s to “do my own thing”: things like sailing and house carpentry, and I more or less forgot about my days at MDC Systems. But Jay didn't forget about me.
In the late 1990s, when Jay and Peter Wallace were putting together a construction management and claims analysis department at Deloitte, Jay gave me a call and asked if I was interested in joining them. I was completely tied up as executor of my mother's estate and had to turn down Jay's offer.
But Jay persisted. He called again just as I was wrapping up the estate work, so I agreed to give it a try. It was the best decision I could have made. In conjunction with Jay, I did my best work at Deloitte. I was never sure that was the case. But Jay would often say to me: “Oh Keet, I have more confidence in you than you have in yourself.” He could always raise a smile.
After Jay retired from Deloitte he and I worked freelance on several

projects that Jay somehow managed to shake out of the bushes. We didn't have an office; we worked out of the Pandya kitchen in Mt. Laurel, NJ. It was pretty much the same as before: Jay would have an insight as to what the final answer was then we'd spend days fighting about how to prove it.

There was one perk to working that way that I didn't have at any other time in my professional career: every day Aruna prepared some fantastic combination of Indian dishes for Jay and me to enjoy at lunch time. Flavors available nowhere else!

These and many, many other remembrances of Jay are firmly woven into the fabric of my life. I miss him but never will forget him.
