Paul J. Klaus, Jr. of Maitland, Florida, passed away gently into the loving arms of our Lord on Friday, December 14, 2018. Paul was born in Rochester, New York on December 3, 1944. He was preceded in death by his parents, Dorothy and Paul J. Klaus, Sr. Paul is survived by his loving wife, Judy, their children, Kimberly Klaus Schmitt (C.
