“ I'd like to share the speech that I read at Grandma's celebration of life:

*I was blessed to be the youngest grandchild of Sandra Brady. That really is the word for it - blessed. We are all blessed to have gotten to share our lives with her, and now that she's gone, we're blessed to be able to look back at our memories with her. Memories that will always make us smile and laugh.*

*It's good to be here, to get to celebrate Grandma with so many loved ones. It's tough to be the youngest knowing that I got the least amount of time with her... but no matter how much time you have, it never feels like enough.*

*People say “you don't know what you have till it's gone,” but not with Grandma. We all knew what a treasure she was. We all wanted to spend time with her and talk to her as much as possible. We all loved her endlessly, and she loved us. No question about it.*

*The past couple months, I got closer to Grandma. I would call her and tell her all these stories about what's going on in my life. It could be funny or stupid or mundane and she would give her full attention no matter what. If I got self-conscious and thought I was talking too much, she'd shut that down fast and tell me that she loves to listen. She genuinely cared. She mentioned something one day, something small I had told her about weeks ago, and I was pretty surprised. I said “wow I can't believe you remembered that” and she said “I'm a really good listener.” she really was.*

*It's rare that you can talk to someone and REALLY feel listened to. She did that for so many people. I wanted to do that for her, I wanted to listen and I wanted to learn everything about her. But how can you even do that? How can you absorb all 79 years of a person's life? But I would think about it a lot - I didn't want her to leave without learning everything about her. Then someone asked me - Does someone know everything about YOU? Well, no. Do you WANT someone to know everything about you? Well dang I hadn't thought of it like that, definitely not. That's not how people are and that's not how life works. We spread our lives around and share pieces of it with different people. Grandma gave bits of her life to everyone, she HAD shared it. And I'm grateful to have gotten to share some of it with her.*

*On the last day that I got to spend with Grandma, we got together to watch TV. She loved British TV, loved that dry sense of humor, and so did I. I was really happy to get to have a shared interest with her along with all the old-timey movies. Every new episode of a show I watched, I'd call her up to tell her about it. She'd laugh so hard and I got to laugh with her, it's like we were watching it together. On that last day after binge watching a show, I drove her home. In the car I started to tear up and I just had the overwhelming urge to ask questions. I asked her about the places she'd lived. Grandma said that Germany was her favorite because she and Grandpa made lots of friends and always went out and did fun things. She said that Virginia was her least favorite because she didn't have that, no real company. It makes a lot of sense - she was a people person. The epitome of one - she loved being around people and people loved being around her.*

*It's nice that she's with Grandpa now, and all the other people that she loved and*

*that loved her. I'm sure she's making them all laugh just like she did with us. Grandma, thank you for everything. We love you to infinity and back.*
